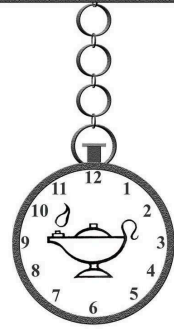
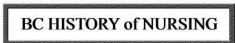

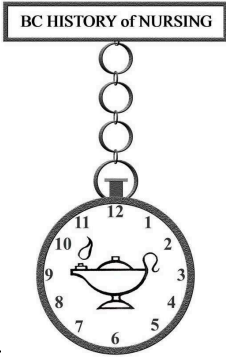

## CONDITIONS OF ACCESS AND USE FOR BCHNS ARCHIVES

BCHNS Archival Collection (1990 to 2020) is housed in The UBC Library Rare Books and Special Collections (RBSC). The collection is available to students, researchers and all interested members of the public. BCHNS is an independent society run by volunteers and is dependent on donations for funding.

Artifacts and other archival materials not housed at RBSC are located at the BCHNS offices in the UBC School of Nursing.

Our web site is a useful place to start the search.

1. Archival materials located at UBC SON must be used within the confines of the Archival office.
2. To preserve all archival documents the use of pens is not permitted in archives.
3. Food and beverages are not permitted in Archives.
4. All materials require careful use and handling.
5. Electronic devices may be used for making notes directly from documents.
6. Photocopying of documents is performed by a member of the Archives Committee within the confines of the Archives office.
7. There is a nominal charge for photocopying.
8. The Archives Committee will determine which documents and photos are restricted and which may be photocopied.
9. With the permission of the Archives Committee, personal electronic devices may be used to copy/scan selected documents and photos within the confines of the Archives office.
10. Proper citation and acknowledgement must be given to BCHNS for any material found in archives and used in any paper, research, publication or display.
11. Researcher should inform the Archives Committee if they intend to publish or use material for a display or exhibition.
12. THE RESEARCHER IS RESPONSIBLE FOR OBTAINING COPYRIGHT PERMISSION TO USE ALL MATERIALS INTENDED FOR EXHIBITION AND/OR FOR PUBLICATION. BCHNS holds copyright to most of the collection but it is the responsibility of the researcher to determine this.

BCHNS Archives would greatly appreciate a complimentary copy of any work written using material from our Collection.
