President's message

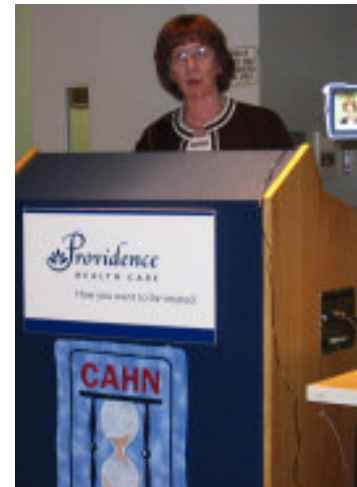

Conference Planning

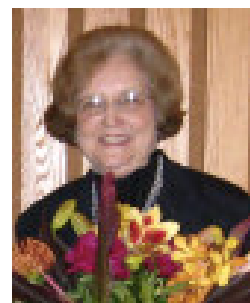

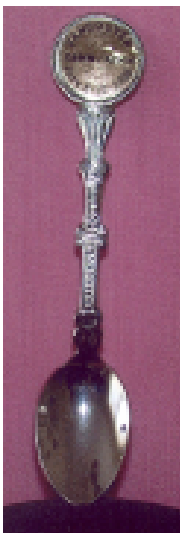

Nurses and the creation of historic memory



Opening Hannah Lecture

This paper will explore the pioneering role of nurses in the commemoration of Canadian women's history through historic plaques, monuments and sites and suggest some reasons that nurses appear early and prominently in the efforts to commemorate women in history. The work of nurses, particularly military nurses, combines a nurturing, 'womanly,' role with a non-traditional role. By entering into the military, by lending aide to the defense of Canada, by demanding and achieving professional status, nurses symbolically placed women in the public sphere as history makers.

One of the earliest and most prominent examples of nurses being recognized for their role in the history of Canada was made possible by the concerted efforts of the Canadian Nurses Association who launched a successful campaign to memorial the nurses who died in The Great War. The Nurses Memorial in the Parliament building was unveiled in Ottawa in 1926, and it set a precedent for women in the creation of history.

The paper will also examine trends in women's history commemoration from the inception, in 1919, of Parks Canada's advisory body, the Historic Sites and Monuments Board of Canada to the present, vis a vis nurses. The first woman to be commemorated was not a nurse, but a woman playing a military role—Madeleine de Vercheres, who defended the family fort from attacking Iroquois in 1692. Later in the century, a few elite women who had achieved national prominence were included among the history makers. These included Margaret MacDonald and Georgina Fane Pope, both military nurses. Following the 1970's, fuelled by the rise of women's history and the women's movement; there was an increase in the number of women's history designation and a widening of scope. Now we are seeing a shift toward recognizing women's collective efforts, through organizations active in social welfare, education and health. In the field of nursing we have seen recent designations of five nurses' residences as representative of the collective achievements of nurses, of two outpost nursing stations and a few nursing leaders, outside of the military sphere.

Through the blending of traditional and non traditional roles, as exemplified in the 1926 nurses' memorial, nurses have been among the first to gain recognition in public spaces as women who made history. Nurses helped open the door to a fuller exploration of women's history in memorials, plaques and national historic sites.

CAHN AGM and highlights



Box lunch Friday June 9th allowed folks to join the CAHN Annual General Meeting chaired by Marg Gorrie, President (right) and assisted by Geertje Boschma, Vice President (left).

The CAHN/ACHN AGM was held on June 9th.

Much of the recent work of the organization has focused on the Vera Roberts Endowment. Florence Melchior, chair of the Scholarship and Awards Committee reviewed this initiative, through which interest from the \$200,000 endowment will be used to fund historical research and publication on the history of northern nursing. During the past year, an ad-hoc sub-committee of the Scholarship Committee was formed (co-chaired by Judith Hibberd and Florence Melchior) to set up guidelines and new terms of reference. The main terms specify

awards will be given for original scholarly research and publication of new knowledge on the history of Northern Nursing in Canada. Eligible applicants include graduate and post-doctoral students, established researchers in nursing history and persons with informal experience in historical research. The terms will be posted on the CAHN/ACHN website (<http://www.cahn-achn.ca>), along with the guidelines. The first award will be made in 2007, with a deadline for applications of February 1, 2007.

Congratulations to Chris Dooley who won the annual CAHN/ACHN scholarship this year.

The 2007 conference will be held jointly with the Canadian Society for the History of Medicine at the Congress of Humanities and Social Sciences in Saskatoon. The 2008 conference will be an international conference and will be held in Toronto.



“Florence’s Web:” Links that help discover, preserve and disseminate nursing history

In recent years there has been a proliferation of resources related to the history of nursing – thanks in no small way to organizations such as the Canadian Association for the History of Nursing / Association canadienne pour l’histoire du nursing. This presentation will peek into the tangled web of agencies, institutions, and organizations that contribute to the development of history of nursing in Canada today. A wide number of networks exist – but often nurses, including nurse historians and researchers as well as history of nursing organizations, are not recognizing and using them to the full extent. That matter is also of concern because many of the nodes on the network compete for financial resources. This brief overview, or “momentary glimpse,” will attempt to identify and briefly describe various institutions and organizations that form parts of the history of nursing web. As well, it is hoped that this presentation will stimulate discussion about ways that nursing historians, researchers, teachers, archivists and organizations can strengthen the web as they attempt to discover, preserve, protect and disseminate knowledge and materials about nursing history.

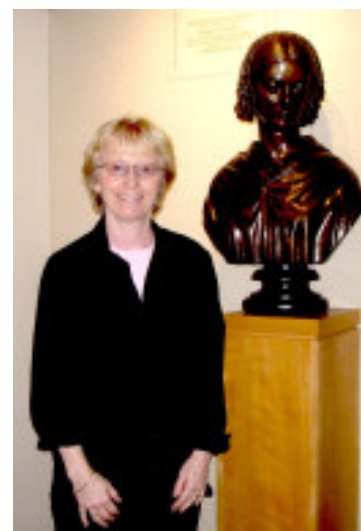
Member News

Her book is still selling well and a recent new review strongly recommended it. Betty had a busy year, with a trip to Northern Ireland and London in 2005, then a successful hip replacement. This May she took a trip to Calgary for the 60th anniversary of her graduation from the Calgary General Hospital School of Nursing.

Cathy Ebbehoj has been much honored recently for her contributions at UBC. This summer, she received the 2006 Slonecker Award from the University of B.C. Alumni Affairs Office. This award recognizes a UBC staff member who volunteers time and talents to the Alumni. Cathy, who was honored in 2005 with an Alumni Achievement Award, this year also garnered the "Last Class" award given on the final day of the year by Nursing students to their "first-class teacher."

Honorary Life Member **Helen Shore** has recently been active on her various projects to increase knowledge about Vancouver's early nurses. Helen has had her biographical entry on Sister Frances Redmond, one of Vancouver's earliest nurses, accepted for publication by the *Canadian Biographical Dictionary*; the multi-volume *Dictionary* is one of Canada's most prestigious reference resources, and provides authoritative biographical information on historic figures. As well, Helen recently unveiled the Isabelle Maud Hill Memorial Fountain, which she generously donated for the Healing Garden at the Vancouver Health and Home Care Society's Family Respite Centre; the Society was formerly the local Victorian Order of Nurses (VON) branch. Ms. Hill was the first permanent VON nurse in Vancouver, hired in December 1901.

Sheila Zerr was recently the guest speaker at the annual tea of the Royal Jubilee Hospital Nurses Alumnae Association in Victoria. She and co-author **Glennis Zilm** went to promote their new book *Labor of Love: A Memoir of Gertrude Richards Ladner 1879-1976*. **Lenore Radom**, who is treasurer of the RJH Alumnae, was also in costume at the book signing.

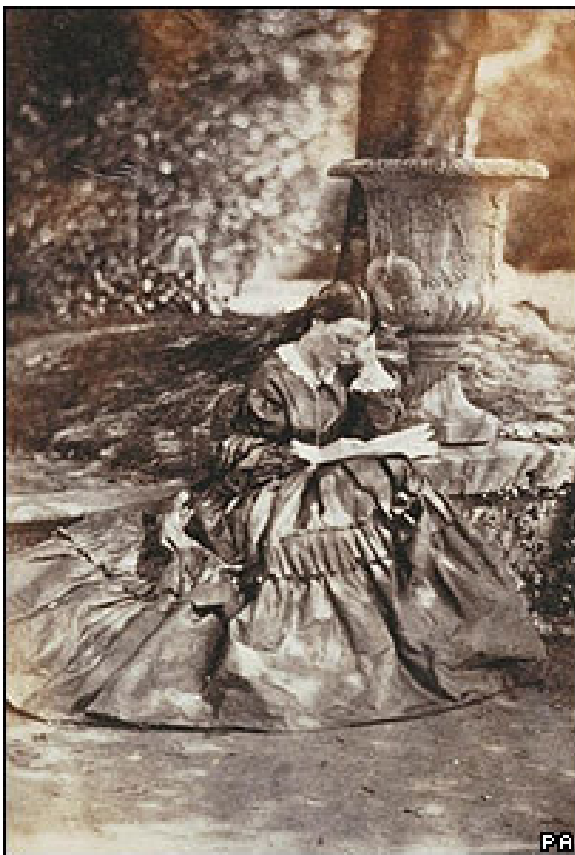
